If the Minor is injured while acting as an unpaid member of PLG Arts volunteer staff, **the Minor is covered by PLG Arts' liability insurance.**

In consideration for the Minor being permitted by PLG Arts to volunteer, I hereby agree that I assume all responsibility for the death, personal injury or property damage sustained by the Minor as a result of or in connection with the Minor's participation as a volunteer, except in the case of gross negligence by another party. I agree for myself and for the Minor to release, discharge, indemnify and hold harmless PLG Arts, its past, present, and future Officers, Directors, Employees, Volunteers, Agents and Contractors, from any and all claims, damages and liability to me or to the Minor or to any person claiming under, through or on behalf of either of us, arising out of or connected in any way with the Minor's participation as a volunteer with PLG Arts.
